TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping Up of Highways (County of Devon) (No. SW2) Order 1981" authorising the stopping up of a length of Albert Road, Torquay, Devon.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 30th March 1981, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SALMON AND FRESHWATER FISHERIES ACT 1975

Fishery Byelaws

Notice is given that the Thames Water Authority ("the Authority") intend after the expiration of one month from the publication of this notice to apply to the Minister of Agriculture, Fisheries and Food for confirmation of byelaws made under the Salmon and Freshwater Fisheries Act 1975. The byelaws substitute for the Authority's existing byelaws relating to the undermentioned matters, as confirmed by the Minister on 6th June 1978, new byelaws differing in effect as indicated below:

Annual Salmon and Trout (Excluding Rainbow Trout) Close Season for Rod and Line.

In any enclosed reservoir, lake or pond into which or from which fish cannot normally swim from or to other waters the annual close season for fishing for trout (other than rainbow trout) with rod and line shall be the period between 29th October and the 1st April following.

Prohibited Modes of Fishing.

A further exception is made to permit fishing with rod and line for salmon, trout, or rainbow trout during the annual close season for freshwater fish with a minnow taken from a minnow trap for use as bait in the waters from
