4777/81 (COM (81) 31 Final). Relations with the State of Israel: Proposal for a Council Regulation concluding a Protocol to the Agreement between the EEC and the State of Israel to take account of the accession of the Hellenic Republic to the Community; Proposal for a Council Regulation laying down the arrangements applicable to trade between the Hellenic Republic and the State of Israel; Draft Decision of the Representatives of the Governments of the Member States of the European Coal and Steel Community, meeting within the Council, laying down the arrangements applicable to trade between the Hellenic Republic and the State of Israel in products covered by that Community.

Recommendation for a Council Decision concerning the negotiation of an Exchange of Letters with Yugoslavia amending Annex A to the Interim Agreement on trade and trade co-operation and to the Co-operation Agreement, approving that Exchange of Letters and adopting the Regulations concerning its conclusion; Recommendation for a Council Decision authorising the Commission to negotiate an Agreement in the form of an Exchange of Letters amending Annex A to the Interim Agreement between
