

(iii), (iv) and (v) above may be by coins of the denomination of 10 new pence.

(b) the excess charge payable to the City Council in respect of those metered parking places in the streets listed in Schedules 1 and 2 to this notice would be £8; in respect of those streets listed in Schedules 3 and 4 the charge would be £4; in respect of those streets listed in Schedule 5 the charge would be £2; and the excess charge period in all cases would be one hour.

(c) in respect of the residents' parking places in the streets listed in Schedule 6 to this notice, the payment for the use of the parking places would be by the purchase of a parking token from the City Council at a cost of 25 new pence for any period during any one day and by the affixing of that token to the calendar, combined with a valid permit within the space thereon appropriate to the date on which the vehicle is left in the parking place, and the parking card must be displayed on the vehicle. Such charge would not be payable if a valid season ticket (£9 for three months and £32 for twelve months respectively) running from the beginning of the month in which it is issued, is displayed.

(d) When the proposed Order comes into operation any resident who holds a parking card for the Belgravia, Knightsbridge and Pimlico area which is valid on that date may continue to use that parking card for the remainder of the period for which it remains unexpired. If a valid parking card issued under the provision of the Order of 1967 or of 1968 is surrendered after the coming into operation of the proposed Orders then the refund of the fee paid in respect of that parking card will be as provided in the relevant Order.

The period for which vehicles may not return to a metered parking place would continue to be one hour and the unexpired time shown on the parking meter may be used free of charge. The hours during which the vehicles may be left, and the classes of vehicles which may be used free of charge. The hours during which in a parking place are as specified in the Orders to be amended.
