Notice is hereby given that the Borough Council of Wigan (hereinafter referred to as "the Council") acting on behalf of the Greater Manchester County Council pursuant to arrangements made under section 101 of the Local Government Act 1972 in exercise of the powers of the said County Council under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 and all other enabling powers to propose to make an Order the effect of which will be:

To prohibit any person from causing or permitting any vehicle to wait on the roads or lengths of road specified below during the times also specified.

The proposed Order contains exempting to permit waiting for the purposes of boarding or alighting loading or unloading, the removal of furniture, funerals, building operations or work on or under the length of road. Disabled persons' vehicles displaying the relevant disabled persons badge will be allowed to wait for up to 2 hours return prohibited within 1 hour.

The proposed Order is to introduce waiting restrictions along a road called Dicconson Street along the south-west side thereof from the junction with Swinley Road for a distance of 10 metres. No waiting 8.30 a.m. to 6.30 p.m. Monday to Saturday.

Thomas Street, 8 a.m. to 6 p.m., Monday to Friday, west side from a point 15 metres north of the northerly

kerb-line in Oliver Street for a distance of 25 metres in a southerly direction.

Thomas Street, 8 a.m. to 6 p.m., Monday to Friday, west side for 45 metres from Tyldesley Road, East side for 15 metres from Tyldesley Road.
