The Camden (Prescribed Route) (No. 2) Experimental Traffic Order 1981

Notice is hereby given that the Greater London Council on 24th April 1981 made the above-mentioned Order under section 9 of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974 and as modified by the Greater London Council (General Powers) Act 1974.

- 2. The effect of the Order will be to prohibit the "U" turn by vehicular traffic proceeding in a north-easterly direction in Theobald's Road at the north-eastern extremity of the central reservation which lies opposite Mercury House, Nos. 110 to 124 Theobald's Road.
- 3. Exemption has been provided in the Order in respect of anything done:-
- (a) with the permission or at the direction of a police constable in uniform;
- (b) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.
- 4. The Order provides that in pursuance of section 9 (5) of the Road Traffic Regulation Act 1967, the Chief Engineer of the Council's Transportation and Development Department or some person authorised in that behalf by him, may, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by the Order runs, modify or suspend the Order or any provision
- 5. A copy of the Order, which will come into operation on 18th May 1981, and of the Council's statement of reasons for making the Order can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 6 months from that date in Room B.21, The County Hall, London SE1 7PB.
