The Borough of Cheltenham (Off Street Parking Places) (Variation No. 2) Order 1981 and The Borough of Cheltenham (Off Street Parking Places) (Pay and Display) (Variation No. 1) Order 1981

Notice is hereby given that Cheltenham Borough Council in exercise of the powers conferred on it under sections 31(1) and 84(D) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 (which said Act of 1967 as so amended hereinafter referred to as "the Act of 1967") and of all other powers it enabling in that behalf and after consultation with the Chief Officer of Police in accordance with section 84C(1) of the Act of 1967 has made the above Orders the effect of which will be to:—

- (3) increase the Parking Tickets charge and vary the Periods for which vehicles may wait in respect of Bath Road/Bath Parade Rodney Road, High Street, Portland Street and Grosvenor Terrace Car Parks in the following manner:—

15p up to 1 hour 20p up to 2 hours 30p up to 4 hours 50p up to 6 hours 80p over 6 hours Proposed charge and period for which vehicle may wait

20p up to 2 hours 30p up to 3 hours 40p up to 4 hours 50p up to 6 hours 80p over 6 hours

(4) revoke the Parking Places Byelaws made by the Mayor Aldermen and Burgesses of the Borough of Cheltenham on 6th April 1936 which was confirmed by the Minister of Health on 17th August 1936 in respect of Rodney Road Car Park and Royal Crescent Car Park.

The Orders which come into effect on 5th May 1981 may be examined at the undermentioned address on Mondays to Fridays between 9 a.m. to 1 p.m. and 2.15 p.m. to 5 p.m.
