Proposed Works at Hornsea-Scheme 5

Notice is hereby given that the Holderness Borough Council acting in their capacity as Coast Protection Authority, hereby give notice that they propose to carry out coast protection works under section 5 (1) of the above Act as briefly described hereafter, at Hornsea, North Humberside.

The work will consist of the reconstruction of roynes at South Promenade and two groynes at North

groynes at South Promenade and two groynes at North Cliff, the construction of a new apron and encasement to the sea wall between Marine Hotel and New Road and flank protection works to the South Cliff revetment.

The estimated cost of the work is £645,000.

ROAD TRAFFIC ACTS

BUCKINGHAMSHIRE COUNTY COUNCIL

The Buckinghamshire County Council (Various Roads, Buckingham) (Prohibition and Restriction of Waiting) Order 1981.

Notice is hereby given that on 23rd April 1981 the Buckinghamshire County Council made the above-named Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Order, which will come into operation on 11th May 1981, is to prohibit any vehicle to wait at any time in certain lengths of Mitre Street, Hunter Street, Lenborough Road and Nelson Street.

Exemptions to the Order will permit;

- (1) Waiting with the permission of a police constable in uniform or a traffic warden.
- (2) Waiting for so long as may be necessary: (a) for persons to board or alight; (b) for goods to be loaded or unloaded; (c) for enabling works to be carried out; (d) in pursuance of statutory powers or duties; and
- (3) The waiting of disabled persons' vehicles in accordance with the "Orange Badge" Scheme.

A copy of the Order, together with a map showing the lengths of road concerned, may be examined at:
