Notice is hereby given that on 5th May 1981 the Warwickshire County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit the waiting of vehicles (except upon the direction or with the permission of a police constable in uniform or of a traffic warden) in lengths of road in Brownsover, Rugby as mentioned in the Schedule below.

The Order will come into force on Monday, 11th May

Exceptions will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the

road and the supply of gas, water or electricity.

A copy of the Order, together with a map showing the lengths of road affected may be inspected at the County Secretary's Department, Shire Hall, Warwick, on Mondays to Fridays inclusive, during normal office hours.

Any person who desires to question the validity of the

Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended, or on the grounds that any requirements of that Act or of any instrument made under it has not been complied with in relation to the Order may within 6 weeks from the date of the making of the Order apply to the High Court for this purpose.

- 1. Helvellyn Way, both sides, for a distance of 15 metres from its junction with Hollowell Way.
- 2. Hollowell Way, both sides, from a point 15 metres north of its junction with Patterdale, southwards to a point 60 metres south of its junction with Helvellyn Way.
- 3. Patterdale, both sides, for a distance of 15 metres from its junction with Hollowell Way.
