#### DECLARATION OF NATURE RESERVE

#### *Communities of Llangadwaladr, Llangeinwen, Newborough and Trefdraeth County of Gwynedd*

Notice is hereby given in pursuance of section 19 of the above-mentioned Act that by the Newborough Warren and Ynys Llanddwyn Nature Reserve No. 7 Declaration 1981 made on 7th May 1981, the Nature Conservancy Council declared that the land containing 675.82 hectares (1670.01 acres) or thereabouts situate in the communities of Llangadwaladr, Llangeinwen, Newborough and Trefdraeth in the County of Gwynedd and shown edged red on the plan attached to the said Declaration has been acquired and is being held by the Council and that the land is being managed as a Nature Reserve.

Notice is also hereby given in pursuance of section 19 (3) of the above-mentioned Act that the Nature Conservancy Council further declared, in reference to the Newborough Warren and Ynys Llanddwyn No. 3 Declaration 1956, made on the 27th September 1956, that the land containing 12.26 hectares (30.30 acres) or thereabouts situate in the communities of Llangadwaladr and Newborough and shown edged blue on the aforesaid plan attached to the first-mentioned Declaration has ceased to be held by the Nature Conservancy Council and to be managed as a Nature Reserve.

Certified copies of the first-mentioned Declaration with plan attached have been deposited for public inspection free of charge at the office of the Ynys Mon-Isle of Anglesey District Council in Llangeinwen and at the office of the Gwynedd County Council in Caernarfon from Monday to Friday inclusive during the normal office hours.
