## Raby Road

(a) To remove the existing "No waiting 7 a.m. to 7 p.m." restriction on the east side of Raby Road from its junction with Church Square for a distance of 42 metres in a northerly direction.
(b) To prohibit waiting at any time on the east side of Raby Road from its junction with Church Square for a distance of 147 metres in a northerly direction.
(c) To remove the existing "No waiting 7 a,m. to 7 p.m." restriction on the west side of Raby Road from its junction with Church Square to its junction with Swainson Street a distance of 68 metres.
(d) To prohibit waiting at any time on the west side of Raby Road from its junction with Church Square to its junction with York Road a distance of 480 metres.

## Swainson Street

(a) To remove the existing "No waiting 7 a.m. to 7 p.m." restriction on the east side of Swainson Street from its junction with Raby Road for a distance of 12 metres in a southerly direction and replace it with "No waiting at any time."
(b) To prohibit waiting at any time on the north side of Swainson Street from its junction with Raby Road for a distance of 16 metres in a westerly direction.

## Tees Street

(a) To create a one-way street allowing driving only in a westerly direction.
(b) To prohibit waiting at any time on the north side of Tees Street from its junction with Avenue Road for a distance of 6 metres in an easterly direction.
(c) To prohibit waiting at any time of the north side of Tees Street from its junction with Raby Road for a distance of 8 metres in a westerly direction.
(d) To prohibit waiting at any time on the south side of Tees Street from its junction with Avenue Road for a distance of 6 metres in an easterly direction.
(e) To prohibit waiting at any time on the south side of Tees Street from its junction with Raby Road for a distance of 8 metres in a westerily direction.

## Wharton Street

(a) To prohibit waiting from 7 a.m. to 7 p.m. on the east side of Wharton Street from its junction with Lowthian Road for a distance of 6 metres in a southerly direction.
(b) To prohibit waiting from 7 a.m. to 7 p.m. on the west side of Wharton Street from its junction with Lowthian Road for a distance of 6 metres in a southerly direction.
York Road, to prohibit waiting at any time on the east side of York Road from its junction with Raby Road for a distance of 21 metres in a southerly direction.
A copy of the Order and a map showing the restricted roads are available at the Civic Centre, Victoria Road, Hartlepool, Monday to Friday between the hours of 9 a.m. and 4.30 p.m.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order you may, within 6 weeks from 11th May 1981 apply to the High Court for this purpose.

Orchard Street on west side from 300 feet south of South Street to 288 feet east of St. James' Street.
Orchard Street on east side from 288 feet east to 330 feet east and north of St. James' Street.

Orchard Street on east side from 525 feet north and east to 570 feet north and east of St. James Street.

St. John's Road on west side from 45 feet south of Cypress Road to 25 feet south of Elm Grove.
St. John's Road on west side from 25 feet north to 280 feet north of Elm Grove.

St. John's Road on east side from 50 feet south of Elm Grove to 45 feet south of Cypress Road.
West Street on both sides from Trafalgar Road to 30 feet north thereof.
(b) To prohibit the waiting of vehicles between 8 a.m. and $6 \mathrm{p} . \mathrm{m}$. in the following length of road:'

Catherine Terrace on both sides from Banner Lane to Albany Road.
(c) To prohibit the waiting of vehicles between 8 a.m. and 6 p.m. weekdays in the following lengths of road:
Chapel Street on south side from 25 feet east to 135 feet east of Union Street.
St. John's Road on east side from Drake Road to 50 feet north of Elm Grove.
(d) To limit the waiting of vehicles to 1 hour in any 2, 8 a.m. to 6 p.m. weekdays in the following length of road:

Orchard Street on east side from 330 feet east to 525 feet east and north of St. James' Street.
(e) To prohibit the waiting of vehicles at any time and the loading and unloading of vehicles at any time in the following length of road:

South Street on north side from 100 feet east to 175 feet east of St. James' Street.
(f) To revoke the no waiting at any time restriction in the following lengths of road:

Sea Street on south-west side from 25 feet southeast to 115 feet south-east of Quay Street.
