

- (f) Prohibit any vehicle from proceeding in either Diamond Street or Silver Street during specified hours, Monday to Friday.

With regard to (f) above, there will be exceptions in the proposed Order to permit access to property.

Full details of the proposals are contained in the draft Order which, together with a plan showing the lengths of roads to which the above proposals relate and a statement of the Council's reasons for proposing to make the Order, may be examined during normal office hours (except Public Holidays) Monday to Friday at Room 308, Civic Centre, Barnstaple.

#### DYFED COUNTY COUNCIL

*The County of Dyfed (B4312 at Llansteffan) (Restricted Road) Order 1981*

Notice is hereby given that on 12th May 1981, the Dyfed County Council made an Order under sections 72(3), 73(1) and (3) of the Road Traffic Regulation Act 1967, as amended

by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of this Order is that length of road specified in the Schedule to this notice becomes subject to a speed limit of 30 m.p.h.

The Order will come into operation on 19th May 1981, and a copy of the Order, together with a map showing the length of road affected may be examined at the offices of the Dyfed County Council at County Hall, Carmarthen, during normal office hours.

Any person who desires to question the validity of this Order or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or, on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within 6 weeks of the date on which the Order was made, apply to the High Court for this purpose.
