#### SCHEDULE 1

*No Waiting at any time*

**Avebury Road**, both sides, from its junction with Downton Road to a point 14 metres west of that junction.

#### **Downton Road**

East and north sides, from its junction with Penhill Drive to a point 14 metres north of its junction with Minety Road.

North side, from a point 14 metres west of its junction with Ramsbury Avenue to a point 20 metres east of that junction.

South side:

from a point 14 metres west of its junction with Ramsbury Avenue to its northern junction with Penhill Drive;

from its southern junction with Penhill Drive to a point 14 metres west of that junction;

from a point 14 metres east of its junction with Southwick Avenue to a point 2 metres west of its junction with Rushall Close.

West side:

from a point 35 metres south of its junction with Avebury Road to a point 35 metres north of that junction;

from a point 14 metres south of its junction with Minety Road to a point 14 metres north of that junction.

East side, from its northern junction with Penhill Drive to a point 14 metres north of that junction.

#### **Hannington Close**

North side, from its junction with Ramsbury Avenue to a point 14 metres east of that junction.

North and east sides, from a point 14 metres west of its junction with Minety Road to its junction with Downton Road.

South and west sides, from a point 14 metres west of its junction with Chippenham Close to a point 20 metres south of its junction with Hannington Close.

#### WOKING BOROUGH COUNCIL

*The Borough Council of Woking (Commercial Way, Woking) (Prohibition of Driving) Order 1981*

Notice is hereby given that the Woking Borough Council on behalf of the County Council of Surrey pursuant to arrangements entered into under section 101 (1) (b) of the Local Government Act 1972 and in exercise of the powers contained in section 1 (1), (2), (3) and 84 (D) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974, propose to make an Order.

The effect of the proposed Order will be to prohibit any vehicle, including motor cycles and bicycles, from proceeding in that length of Commercial Way which extends from a point 14 metres north-east of the north-eastern boundary of No. 28 Commercial Way to a point 5 metres north-east of the junction with Chapel Street. Vehicles used for police, fire brigade, ambulance, local authority and statutory undertakers purposes will be exempt from this provision.
