South Norfolk District Council (Long Stratton) Public Path Diversion Order 1981

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 14th May 1981 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed as an unopposed Order by the South Norfolk District Council. The effect of the Order, if confirmed without modification, will be to divert that part of footpath 12 in the parish of Long Stratton, running east-north-east for about 70 yards from the Swan Lane/St. Michael's Road junction to a line running south-east from a point about 50 yards further north along St. Michael's Road to join the original path.

If the Order is submitted to the Secretary of State for confirmation, any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.
