Notice is hereby given that an area of approximately 9.9 hectares at Walsall Town Centre in the Metropolitan Borough of Walsall which is more particularly described in the Schedule hereto has been designated a Conservation Area by the Walsall Metropolitan Borough Council as

tion Area by the Walsall Metropolitan Borough Council as Local Planning Authority in pursuance of section 277 of the Town and Country Planning Act 1971, (as amended). The reason for designating this area a Conservation Area is that this area is considered to be an area of special architectural and environmental interest which it is considered is desirable to preserve or enhance.

The effect of such designation is (inter alia) that no buildings within the Walsall Town Centre Conservation Area can be demolished unless specific approval for such demolition has previously been given by the Local Planning Authority. ning Authority.

Six weeks notice must be given to the Metropolitan Borough Council by any person intending to remove branches, lop or fell a tree in the Conservation Area.

In addition, any proposals for alterations to buildings within the Conservation Area will be carefully considered in order to ensure that the character and appearance of

SCHEDULE

An area of approximately 9.9 hectares at Walsall Town Centre in the Metropolitan Borough of Walsall, comprising:

The boundary extends along the centre of the full length of Hatherton Road from its junction with St. Pauls Street to its junction with Lichfield Street. It then continues, via a 10 metres length of Lichfield Street, for 50 metres along the centre of Whittimere Street/Intown Row. To the east side of the YWCA Club, the boundary turns to the south-west and runs alongside the boundary turns to the south-west and runs alongside the club and then to the rear of Lichfield Street Motors and No. 133 Lichfield Street; it then follows the rear curtilage boundary of Bayard House and No. 138 Lichfield Street, extends 20 metres along the centre of Intown in a north-westerly direction and then continues to the south-west along the rear of nos. 139-151 Lichfield Street. It emerges into Bridge Street between Nos. 45 and 47, and turns to the west for eight metres, along the centre of Bridge Street. The boundary then turns again to the south-west and follows the rear boundary of the Berni Inns Restaurant (excluding the service yard entrance and single storey above), coming out onto Freer trance and single storey above), coming out onto Freer Street on the north-west side of No. 1. It passes for 10 metres along the centre of Freer Street, to the north-west and then south-westwards between No. 42 and Leicester Buildings. The boundary then extends to the rear of Leicester Buildings (to the north of Nos. 1 and 2. Old Scapers). Greekherry House, and Jerome Chambers. 2 Old Square), Greybury House, and Jerome Chambers, follows the line of the rear of the new part of the Tesco's store, leading into Digbeth via the centre of the service road between Nos. 7 and 9 Digbeth. It then crosses Digbeth and continues along the centre of Lower Hall Lane, as far as its junction with Newport Street. The boundary then passes westwards along the centre of Newport Street, then along the eastern and southern boundary of the Stand Tavern P. H. and then southwards along the centre of Little Newport Street, northwestwards along the centre of Caldmore Road, northwards along the centre of Bradford Street and then north-westwards along the centre of the western leg of Bradford Place. It continues into Bridgeman Street and then runs northwards for twenty metres to the east side of the Saddlers Centre car park access, before following the old line of the Ford Brook to the rear of the College of Art Annexe. It then extends across the entrance to Bradford Mall, passes between Nos. 4 and 6, and follows the south-east boundary of the Saddlers Centre service yard, emerging onto Park Street and between Nos. 11 and 13. It extends for thirteen metres in a north-westerly direction in the centre of Park Street and then turns to the north-east, passing between Nos. 14 and 16, extending directly to the centre of St. Pauls Street. It then runs to the north-west along the centre of St. Pauls Street to its juncion with Hatherton Road. Road.
