##### HIGHWAYS ACT 1980

*The Cherwell District Council (Horton-cum-Studley Footpath No. 10) Diversion Order (No. 4) 1981*

Notice is hereby given that on 8th May 1981 the Cherwell District Council confirmed the above-named Order as an unopposed Order.

The effect of the Order, as confirmed is to divert the footpath known as Horton-cum-Studley footpath No. 10 from its present route running in a northerly direction for 30 metres from point GR604127 to the Bicester Road, to a new route running in a north-north-westerly direction from point GR604127 for 33 metres along the existing path next to The Paddocks to join the Bicester road approximately 13 metres west of the former junction.

A copy of the Order and the plan contained in it has been deposited and may be inspected free of charge at Bodicote House, Bodicote, Banbury, Oxon, and at Exeter Hall, Oxford Road, Kidlington, Oxon, between 9 a.m. and 4 p.m. on Mondays to Fridays.

The Order becomes operative as from 18th May 1981 but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1980, or on the grounds that any requirement of the Act or of any regulation made thereunder, has not been complied with in relation to the Order, he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 15th May 1981 make an application for the purpose to the High Court.
