#### PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 13th May 1981 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices of Denstone and Ellastone, and altering the name of the parish of Ellastone, in the diocese of Lichfield.

2. Declaring redundant the church of St. Mary the Virgin, Ashbury, in the diocese of Exeter.

3. Appropriating part of the churchyard of the parish church of Burnmoor, in the diocese of Durham, to use by the parochial church council for any ecclesiastical purpose affecting the parish and for vesting the said land in the Durham Diocesan Board of Finance.

4. Uniting the benefices of Combe Martin and Berryarbor, in the diocese of Exeter.

5. Uniting the benefices of Tetsworth; Adwell with South Weston; Lewknor; and Stoke Talmage with Wheatfield, in the diocese of Oxford.

6. Uniting the benefices of Farnham Royal and Hedgerley, in the diocese of Oxford.

7. Uniting the benefices and parishes of St. Stephen, Selly Hill; and St. Wulstan, Selly Oak, and declaring redundant the parish church of the parish of St. Wulstan, Selly Oak, in the diocese of Birmingham.

8. Uniting the parishes of St. James, Didsbury; and Emmanuel, Barlow Moor, in the diocese of Manchester.

9. Uniting the parishes of St. Bartholomew, Armley, and St. Mary, New Wortley, in the diocese of Ripon.

10. (1) Creating the new benefice and parish of St. George, Portsea;
