

DEVON COUNTY COUNCIL

The County of Devon (Fore Street, High Street and Station Road, Totnes) (Traffic Regulation) (Experimental) (Extension No. 2) Order 1981.

Notice is hereby given that on 15th May 1981, Devon County Council made an Order under section 9 of the Road Traffic Regulation Act 1967 as amended, extending the operation of the Experimental Order affecting traffic regulation as specified below in lengths of road at Totnes until 18th November 1981.

- (a) reversing the direction of the one-way Order on Fore Street between Station Road and The Plains;
- (b) Prohibiting the driving of any motor vehicle and the waiting of any motor vehicle on that portion of High Street which lies between its junction with South Street/Fore Street and Castle Street between the hours of 10 a.m. and 4.30 p.m.

This Order will come into effect on 18th May 1981.

A copy of the Order together with a map showing the affected lengths of road may be inspected during usual office hours, Monday to Friday, at the offices of South Hams District Council, Follaton House, Plymouth Road, Totnes, or at the address given below.

If you wish to question the validity of this Order or any provision made under it, on the grounds that it is not within the powers conferred by the relevant section of the Act or that any requirement of the Act or any regulation made under it has not been complied with, you may, within 6 weeks of the date of this Order, apply to the High Court for that purpose.

2. Castlemartin to Coxey unclassified road, from the junction with the B4319 at The Pound in a south-westerly direction to its termination at the boundary of Castlemartin Tank Ranges.

(ii) That length of the A4115 road at Templeton which extends from its junction with the A478 road in a westerly direction towards Cross Hands for a distance of 250 metres.
