Barnard Castle Conservation Area

Notice is hereby given that on 3rd March 1981 the Durham County Council in pursuance of their powers under section 277 of the Town and Country Planning Act 1971 designated those parts of Barnard Castle described in the Schedule hereto as a Conservation Area, being an enlargement of the existing Conservation Area.

The present Barnard Castle Conservation Area, which was designated on 7th May 1969, includes the whole of the historic centre of the town, the Bowes Museum, the Barnard Castle School, the Demesne and the frontage of the River Tees from Percy Beck in the north-west down to the sewage works in the south-east.

The river, river banks and associated historic buildings, particularly by Barnard Castle Bridge, are important features in the overall setting of the town and merit inclusion within the Conservation Area.

A plan showing the area designated has been placed on deposit at the offices of the Teesdale District Council, 43 Galgate, Barnard Castle and at County Hall, Durham (Room 1/19B), and may be inspected there during normal office hours.
