

- (2) To limit waiting to 1 hour between the hours of 8 a.m. and 6 p.m. on Monday to Saturday with return prohibited within 1 hour in a certain length of Chiltern Avenue Service Road.
- (3) To limit waiting to 1 hour between the hours of 8 a.m. and 4 p.m. on Monday to Friday with return prohibited within 1 hour in a certain length of The Rise.

Exemptions to the Order will permit:

- (1) Waiting with the permission of a police constable in uniform or a traffic warden.
- (2) Waiting for so long as may be necessary:
- for persons to board or alight;
  - for goods to be loaded or unloaded;
  - for enabling works to be carried out;
  - in pursuance of statutory powers or duties; and
- (3) The waiting of Disabled Persons' vehicles in accordance with the "Orange Badge" Scheme.

The Order provides for the variation of "The Buckinghamshire County Council (Traffic Regulation) (Amersham-on-the-Hill) Order 1967" and The "Buckinghamshire County Council (Amersham-on-the-Hill) (Prohibition and Restriction of Waiting) Order 1974" insofar as they relate to the lengths of road above referred to.

Notice is hereby given that the Buckinghamshire County Council made an Order on 11th May 1981, under sections 1 (1), (2), (3) and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, consolidating the following Orders:

The Order will come into effect on 26th May 1981.
