The North Dorset (Off-Street Parking Places) (No. 1) Order, 1981

Notice is hereby given that the North Dorset District Council has made an Order under section 31 (1) and section 84D (1) of the Road Traffic Regulation Act 1967 (as amended), the effect of which is:

- 1. To revoke all previous off-street parking places orders made by the Council and to re-enact and consolidate existing orders.
- 2. To authorise use of the car parks specified in the Schedule hereto as off-street parking places for the classes of vehicle therein stated subject to the right of the Council to suspend the use of the parking places, in whole or in part, at any time, (except Market Place, Blandford, which cannot be used from 8 a.m. to 6 p.m. on Thursdays and Saturdays).
- 3. To regulate the use of these parking places.
- 4. To authorise and regulate the collection and payment of charges; to impose the charges specified in the Schedule hereto at the times therein shown; to impose a season ticket charge of £20 (twenty pounds) per annum in the case of a motor car; and to make regulations for the purchase and display of parking tickets.
- 5. To impose a charge of £6 (six pounds) payable to the Council where prepayment of the appropriate parking charge is not indicated by the display of the appropriate ticket on or in the vehicle, and to make regulations as to the payment of this
- 6. To make provisions as to the giving of information by the person keeping a vehicle or any other person in respect of a vehicle in any of the parking places specified herein.
- 7. To authorise the Council to arrange for the removal and disposal of vehicles left in parking places in certain circumstances where they are left in contravention of this Order.
- 8. To impose the following time limits for parking a vehicle:
 - (a) Grove Lane Car Park, Stalbridge: 1 hour between 7 a.m. to 6 p.m.
 - (b) Market Place Car Park, Church Lane Car Park and Tabernacle Car Park, Blandford; Bell Street Car Park, Shaftesbury; High Street Car Park, Gillingham, and Church Street Car Park, Sturminster Newton: 2 hours.
 - (c) Any other Car Park: 72 hours.

Note: In the Schedule the expression "Heavy Vehicle" means a goods vehicle having an unladen weight of not less than 3 tons (2.95 metric tonnes).
