In assessing whether or not consent should be granted, planning authorities will take account of the importance of the building to the character or appearance of any part of the

conservation area.

Section 61A of the Act extends the control over trees in conservation areas by requiring that any person wishing to cut down, top, lop, uproot, wilfully damage or wilfully destroy any tree in a conservation area subject to certain exemptions shall give the Local Planning Authority 6 weeks

notice of his intention of so doing.

The extent of the conservation area is described in the
