

no Condition to undertake so considerable an Enterprise. The Prussian Troops that have been quartered this Winter in the Modenese, and the Parmesan, have received some Interruptions in the March from the overflowings of the Rivers; occasioned by the sudden falls of the Waters from the Mountains. However they are already arrived in the Territories of Pavia, and are continuing their March towards Piemont, where all the necessary measures are taken for opening the Campaign, the Army being to be formed about the 10th Instant. The Duke of Berwick arrived at Grenoble the 31st of the last Month, and has begun to Post his Troops in the Passes of the Mountains, for the better Security of those Places during the Campaign.

Venice, June 5. N. S. The Prince de Santo-Bonno having had his Audience of Leave, and received the usual Present, is removing with all his Family to Bologna, where he proposeth to leave his Princess, and will go from thence to the Duke of Anjou's Court at Saragosa, in order to receive that Prince's Commands, before he proceeds to take upon him the Government of Sicily. Our Letters from Constantinople, dated the 24th of April, advise, that the Turks give out that they shall be in a Condition to act against the Muscovites on the Black Sea this Summer, and that they are for that purpose forming a Train of Artillery, and making other warlike Preparations with great Diligence. They write from Naples, that the Viceroy had caused an Ordonnance to be Publish'd, enjoining all the Subjects of France under severe Penalties to depart that Kingdom by a time prescribed, as likewise all the Women, whose Husbands are in the Duke of Anjou's Service in Spain or elsewhere. They continue the Offices in all the Churches in that City upon the account of the late Emperors Death, and the Viceroy has received the Compliments of Condolance in the Name of the Magistracy and Populace on that Occasion.

Berlin, June 13. N. S. Last Thursday his Excellency Mr. Whitworth, the Queen of Great Britain's Ambassador-Extraordinary and Plenipotentiary to the Czar of Muscovy, went from hence for Dresden. Count Gollorkin has received Letters by Express from Jawarow, dated the 8th of May, O. S. importing, that his Czarish Majesty was waiting for the Arrival of the King of Poland, and that the Army of the Muscovites was to be formed by the end of that Month at Braclow, a Town in Podolia, about six Days March from Bender: In the mean time it is assured, that the Turks cannot be ready before the Beginning of July. Count Gollorkin's elder Brother arrived here on Tuesday last, and on Thursday they both set out for Wolfenbuttel, where the Elder has Orders to stay with the Hereditary Prince of Muscovy, and the Younger is to continue his Journey to the Prussian Court now in Holland. The Swedish Troops in Pomerania are not yet drawn together; and we are told that they will not be able to March for want of Money.

Frankfort, June 14. N. S. The Landgrave of Hesse-Cassel is come to the Baths of Slangenback, under a Guard of his Hessian Grenadiers and two Companies of Foot, which are to be quarter'd there during the Landgrave's Residence at that Place. The 6th Instant part of the Enemy's Army, consisting of twelve Regiments of Horse and some Foot, pass'd the Rhine at Fort Keyhl, as did likewise six other Regiments of Horse at Selingen, and encamp'd near Wildstadt; whereupon the Duke of Wirtemberg march'd with some Horse, and two thousand Foot, in order to engage them; but finding 'em advantageously posted, he foraged in sight of their Camp, and a Body of their Horse having been sent out to get Intelligence, were intercepted and entirely defeated by a Party of the Germans, who took about sixty Prisoners, and one hundred of their Horses.

The Commissioners appointed by Her Majesty for governing and managing the Duties on Hides, &c. have thought it convenient to give Notice,

THAT by an Act lately pass'd for laying certain Duties upon Hides and Skins, Tanned, Tawed, or Dress'd, and upon Vellum and Parchment, for the Term of thirty two Years, for prosecuting the War, &c. it is amongst other things enacted and declared, That all and every Tanner, Baril Tanner, Currier, Tawer, Spanilh Leather-dresser, and all other Dressers of Hides or Skins, or pieces of Hides or Skins to be tanned, tawed or dress'd in Horse, Mule, Alom, Salt, Oil, Meal or other Materials whatsoever; and all and every Maker of Vellum and Parchment in Great Britain, shall, before the 24th Day of July 1711, give Notice in Writing to some one or more of the proper Officer or Officers to be appointed for the next Market to the place where any Tan-house, Tan-yard, Work-house, Mill, or other place shall be made use of, for the tanning, tawing or dressing any such Hides or Skins, or pieces of Hides and Skins, or making any such Vellum or Parchment as aforesaid, of their respective Names and Places of Abode, and of every such Tan-house, Tan-yard, Work-house, Mill, or other place for the Tanning, Tawing and Dressing any such Hides or Skins, or pieces of Hides or Skins, Vellum and Parchment as aforesaid, by them respectively used, and of the number and quantity of Hides and Skins in every one of them, and the numbers and kinds of the Hides and Skins, or pieces of Hides and Skins then being in the said Pits and Fats respectively; and that all and every such Tanner, Tawer, Currier, Dresser and Maker as aforesaid, as often as he, she, or they shall change their Places of tanning, tawing or dressing of such Hides or Skins, or pieces of Hides and Skins, or making such Vellum or Parchment, and all and every Person and Persons who shall at any time or times hereafter, during the continuance of this Act, be the Tanner, Tawer, Currier or Dresser of any such Hides or Skins, or pieces of Hides or Skins, or be the Maker of any such Vellum or Parchment as aforesaid, shall give or leave the like Notice of their respective Names and Places of Abode, and of their Tan-houses, Yards, Work-houses, Mills or other places where they shall Tan, Taw or Dress, or intend to Tan, Taw or Dress any such Hides or Skins, or pieces thereof, or make any such Vellum or Parchment as aforesaid, before they or any of them do presume to make use of any Tan-house, Yard, Work-house, Mill or other place, or any Pit or Fats therein, to the end the said Officers may from time to time have due knowledge of all such Tan-houses, Tan-yards, Work-houses, Mills or other places, with the number and quantity of Fats and Pits, where such Hides or Skins, or pieces thereof, shall be tanned, tawed or dress'd, and where the said Vellum and Parchment shall be made, and be the better enabled to take an account of all Hides and Skins, and pieces of Hides and Skins, Vellum and Parchment, chargeable by this Act, that so His Majesty may be the better answered the Duties on the same; and if any such Tanner, Tawer, Currier, Dresser or Maker as aforesaid, shall neglect to give or leave such Notice as is required by this Act as aforesaid, he, she, or they shall for every such Offence forfeit the Sum of 50*l.* one third part thereof to His Majesty, Her Heirs or Successors, and the other two thirds to him or them that shall inform or sue for the same.

And that whereas several Tanners, Tawers, Dressers, Curriers, Sellers of Hides or Skins, or pieces of Hides or Skins tanned, tawed or dress'd, Skinners, Coach-makers, Collar-makers, Saddle-makers, Saddlers, Trunk-makers, Bottle-makers, Merchants and other Sellers and Dealers in Hides or Skins, tanned, tawed or dress'd, and several Makers of Vellum and Parchment, Stationers, Bookbinders, the Commissioners and Officers for the Duties

on Stamp Vellum, Traders or Dealers in such, have or shall have, several Skins, and pieces of Hides or Skins, or pieces of Vellum and Parchment, of the produce of the same: It is enacted, That all and every Tanner, Tawer, Currier, Trunk-maker, or other Dealer in such Hides or Skins, or pieces of Hides or Skins, or Vellum and Parchment, or Stationers, Bookbinders, or other Dealers in Stamp Vellum, or other Possessions, or other Prerogatives, or other Rights, shall, on the 24th Day of June 1711, or before that time, or before the first Day of July 1711, or before the first Day of August 1711, or
