- All planning applications likely to affect the character and appearance of the area will be advertised and representations received will be carefully considered by the Council before reaching a decision on the proposal.
- The felling of trees, other than dangerous trees (and certain other exceptions), can only be carried out after six weeks notice is given to the Council.
- The Secretary of State for the Department of the Environment may implement special control over advertisements within the area.

In addition the Local Planning Authority will, if it deems it necessary, seek approval of the Secretary of State for the Environment to bring under control particu-lar classes of development otherwise permitted by the Town and Country Planning General Development Order.

A plan showing the boundaries of the area, together with a statement setting out the Council's policy for the area, is available for inspection, during normal office hours at Oakley Manor, Belle Vue Road, Shrewsbury.
