The Trunk Road (Erwood, Powys) (Restricted Roads)
Order 1981

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 72, 73 and 84D of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit the driving of motor vehicles at a speed exceeding 30 m.p.h. in the length of road specified in the Schedule below. The Order also revokes the Trunk Roads (40 m.p.h. Speed Limit Direction) (No. 19) Order 1962 and the Trunk Roads (Erwood) (40 m.p.h. Speed Limit) Order 1962.

That length of the Cardiff-Glan Conwy Trunk Road (A470) at Erwood in the County of Powys which extends from a point 200 yards east of the centre line of Erwood Bridge which carries the trunk road over the River Clettwr in a westerly direction to a point 279 yards northwest of the centre line of the said bridge, a distance of approximately 479 yards.
