The County of Devon (Plymouth Road and Priory Avenue, Totnes) (Prohibition and Limitation of Waiting) Order

Notice is hereby given that on 22nd May 1981, the Devon County Council made an Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967 as amended, extending and consolidating existing waiting restrictions at Totnes.

When the Order comes into effect on 1st June 1982, you will not be allowed to leave your vehicle:

1. At any time in the following lengths of road:

Plymouth Road

north side, from its junction with High Street for a distance of 35 metres in a westerly direction;

south side, from a point 16 metres west of its junction with High Street in a westerly direction for a distance of 19 metres.

2. Between the hours of 9 a.m. and 6 p.m. daily for a longer period than one hour (no return within one hour) in the following length of road:

Plymouth Road, south side, from a point 4 metres west of its junction with High Street in a westerly

west of its junction with High Street in a westerly direction for a distance of 12 metres.

3. Between the hours of 9 a.m. and 6 p.m. on any day other than a Sunday in the following length of road:

Priory Avenue, north side, from a point 18 metres west of its junction with Station Road in a westerly direction for a distance of 18 metres.

Exemptions in the Order permit waiting for the purpose of boarding and alighting, loading or unloading, Post Office services, maintenance of the road, supply of gas, water and electricity, in pursuance of statutory powers or duties, taking in petrol, oil or air from a garage. The statutory exemptions for disabled persons' vehicles are included.

A copy of the Order together with a map showing the affected lengths of road may be examined during usual office hours, Monday to Friday, at the offices of South Hams District Council, Follaton House, Plymouth Road, Totnes, or at the address given below.

If you wish to question the validity of this Order or any provision made under it, on the grounds that it is not within the powers conferred by the relevant section of the Act or that any requirement of the Act or any regulation made under it has not been complied with, you may, within 6 weeks of the date of this Order, apply to the High Court for that purpose.
