#### **ROAD TRAFFIC REGULATION ACT 1967**

The County of Wiltshire (Various Roads, Trowbridge) (Prohibition and Restriction of Waiting) Amendment Order (No. 1) 1981.

Notice is hereby given that the Wiltshire County Council intend to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be to amend the waiting restrictions at present in force on lengths of road in Trowbridge as follows:

- (1) Adcroft Street, that the present prohibition of waiting at all times will be extended so as to apply to the whole of the south-west side of Adcroft Street.
- (2) Avon Way, that waiting will be limited to two hours with return prohibited within one hour between 8 a.m. and 6 p.m. on Mondays to Saturdays on the north side of Avon Way between:
  - (i) a point 25 metres east of Canal Road to a point

81 metres west of Kennet Way and
(ii) a point 25 metres east of Kennet Way to a
point 52 metres east of that junction.

(3) Conigre, that prohibition of waiting at all times will apply on the north-west, south-west and southern sides of the area of Conigre to the south-west of the main carriageway between the Bus Station and the Back Street off Street Car Park.

(4) Market Street

(i) that waiting will be prohibited at all times on the south-east side from a point 10 metres north-east of Castle Street for 15 metres north-eastwards;

(ii) that waiting will be prohibited between 8 a.m. and 6 p.m. on Mondays to Saturdays on the southeast side from a point 25 metres north-east of Castle Street for 10 metres north-eastwards. (This replaces the limited waiting at present in force.)

Note. Vehicles licensed as hackney carriages will be allowed to wait on authorised cab ranks on the lengths of road referred to in (3) and (4) (i) above.

This Order will be by way of an amendment of the 1978 Order made in respect of roads in Trowbridge and the usual exemptions will apply.
