A. Prohibit waiting at any time on the following lengths of road

(a) Service Road

(i) North side, starting at a point opposite the gable end of No. 26 Wolverhampton Road and continuing in a south-easterly direction to a point opposite the western boundary of No. 8.

(ii) South side, from the east gable end of No. 28 to the west end of the parking bay opposite No. 12, including both sides of the short connector road to the main carriageway of the trunk road.

(iii) South side, from the east end of the parking bay opposite the boundary between Hangers Green and No. 4 in an easterly direction to the end of the service road where it meets the boundary of No. 2.

(b) Lay-by

(i) West side, from its northern junction with the main carriageway of the trunk road in a southerly direction for a distance of 17 metres.

(ii) East side, for that length of the lay-by between its northern and southern junctions with the main carriageway of the trunk road and including both sides of the two short connector roads from the lay-by to the main carriageway of the trunk road.

B. Limit waiting to 1 hour with no return within one hour on Mondays to Saturdays inclusive

(a) Service Road

(i) North side, from a point opposite the western boundary of No. 8 to the east end of the service road opposite Hangars Garage and including both sides of the short length of road running at right angles which gives access to the service road situated be-tween Hangars Garage and No. 8.

(ii) South side from the west end of the parking bay opposite No. 14 to the east end of the parking bay opposite the boundary between Hangars Garage and No. 4.

(b) Lay-by (i) The remainder of the lay-by not previously defined i.e. on the West side commencing at a point 17 metres south of its northerly junction with the main carriageway of the trunk road thence southwards for the full length of the lay-by and then returning in a the full length direction to its junction with the western north-westerly direction to its junction with the western end of the southern short connector road which leads to the main carriageway of the trunk road.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein. Exceptions will also be provided for disabled person's badge holders.
