- (4) The City Council of Liverpool (Langham Street) (Pro-hibition of Waiting) Order 1981
  - (a) To revoke The City Council of Liverpool (Walton Lane/Spellow Lane/Langham Street) (Prohibition of Waiting and One-Way Traffic) Order, 1971, insofar as it relates to waiting in Langham Street.
  - (b) To prohibit, with certain exceptions, any vehicle from waiting at any time on the sides of lengths of road specified in Schedule 1.
- ) The City Council of Liverpool (Muirhead Avenue East) (Prohibition of Waiting) Order 1981
  - (a) To revoke The City Council of Liverpool (Lower-house Lane/Dwerryhouse Lane) (Prohibition of Wait-ing) Order, 1969, insofar as it relates to waiting on the easterly carriageway of Muirhead Avenue East.
  - (b) To prohibit, with certain exceptions, any vehicle from waiting at any time on the easterly carriageway of Muirhead Avenue East, from its junction with Oak Lane in a south-westerly direction for a distance measured along the said road of 140 metres (459 feet)
- (6) The Parking Places for Disabled Persons (Liverpool) (No. 1, 1974) (Amendment) Order 1981
  - To amend The Parking Places for Disabled Persons (Liverpool) Order No. 1, 1974, as amended by subsequent Orders, so as to authorise the use of the part of road specified in Schedule 2 as a disabled persons' parking place, by residents of the said road who qualify for and hold a valid permit issued by the Council under the provisions of the Order.
