### HONOURS AND AWARDS

The QUEEN has been graciously pleased, on the advice of Her Majesty's Fiji Ministers, to approve the award of The Queen's Gallantry Medal to the undermentioned:

(To be dated 13th June 1981)

(21998) Lance Corporal Netani NAVUTOVUTO, Fiji Military Forces,

On the night of 17th September 1980 an Israeli amphibious raid, with land and naval artillery support, into the Palestinian-controlled enclave surrounding the city of Tyre, including targets close to Fiji troop positions, resulted in a number of civilian casualties. Hearing that a Lebanese woman with a bullet lodged in her arm had been evacuated under fire to a forward platoon position of the Fiji Battalion, Lance Corporal Navotovuto volunteered to go forward to give medical help. In spite of intense artillery fire and showing great resourcefulness, he removed the bullet and stemmed the loss of blood. In rendering this assistance he acted beyond the normal call of duty and his usual responsibilities, and there is no doubt his brave and skilful actions saved the life of the woman. (1 SI)

Captain Epeli Gavidi GANILAU (21534), Fiji Military Forces,

Captain Ganilau displayed conspicuous leadership, skill, and bravery during his 12 months as a Company Commander from August 1979. His unit having killed a leading Palestine Liberation Organisation (PLO) guerrilla commander during a confrontation in late August 1979, Captain Ganilau redeployed his troops and took personal

command in anticipation of a retaliatory attack, and by effective leadership, and professional skill and commendable coolness under fire successfully defended his company positions without casualties to his troops.

Captain Ganilau displayed these personal qualities repeatedly during his 12 months operational service. In September 1979 he was ordered to halt an infiltration by a heavily armed group of PLO guerillas. His skilful deployment of his troops having blocked the guerillas in a tactically disadvantageous position, he revealed his position, and, after speaking to the opposing commander persuaded the group to surrender. As a result of Captain Ganilau's professional handling of a dangerous situation no casualties were sustained by either side, an all too rare example of how to implement UN field policy on not using firearms.

Captain Ganilau's consistently outstanding leadership, his dedication and personal example, which always transcended his regard for his personal safety, were a credit to his regiment, the Royal Fiji Military Forces and to the United Nations Interim Force in the Lebanon. (1A SI)

Second Lieutenant Samuela Alivereti SAUMATUA (21523), Fiji Military Forces.

As Intelligence Officer with the 1st Battalion Fiji Infantry Regiment for 12 months from June 1979, Second Lieutenant Saumatua was responsible for collection, collation, interpretation and dissemination of operational intelligence on various armed factions in South Lebanon. His provision of accurate and timely intelligence not only enabled the Battalion to defend itself but also to anticipate armed confrontations and their worst consequences.

2nd Lieutenant Saumatua's high professional standards and efficiency made him an invaluable member of his own unit and also of UNIFIL which frequently relied on his evaluation of tactical intelligence. 2nd Lieutenant Saumatua's skill, dedication and efficiency contributed significantly to his Battalion's excellent operational record.

(777) Warrant Officer Class 2 Kelevi VAKASAVUWAQA,  
Fiji Military Forces.

On 7th April 1980 Warrant Officer Class 2, Vakasavuwaqa commanded a reserve platoon sent to reinforce an Irish Battalion area of U.N. territory occupied by "rightist" rebel forces and subjected to machine gun and sniper fire causing casualties among the Irish unit. "Rightist" harassment on 12 April, which led to the death of a Fijian soldier, having failed to dislodge the Fijian and Irish troops, the U.N. positions came under artillery attack for several hours. In spite of direct hits on his platoon position W.O.2 Vakasavuwaqa and his men maintained their ground, and the "Rightist" forces had to withdraw. W.O.2 Vakasavuwaqa's leadership under most difficult conditions, together with his resolution and personal conduct under fire were in accord with the high standards of professional conduct. (1B SI)

### TANDRIDGE DISTRICT COUNCIL

#### *The Tandridge Noise Abatement Order 1981*

Notice is hereby given that the Tandridge District Council, in exercise of the powers conferred on them by section 63 of the Control of Pollution Act 1974, propose to make an Order entitled The Tandridge Noise Abatement Order 1981 declaring the area described in the Schedule hereto to be a noise abatement zone.

Subject to the Order and by virtue of sections 63, 64, 65, 66 and 67 of the said Act, if noise emitted from any premises constitutes a contravention of subsection (1) of section 65 or of a condition attached to a consent under this section, the person responsible shall be guilty of an offence.

Section 65(1) provides that the level of noise recorded in the noise level register in respect of any premises is not to be exceeded except with the consent, in writing, of the local authority.

Section 66(1) enables the local authority to serve a noise reduction notice on the person responsible for noise emanating from premises within a noise abatement zone where it appears to the authority that the level of noise is not acceptable and that a reduction is practicable at reasonable cost and would afford a public benefit.

**NORTH BEDFORDSHIRE BOROUGH COUNCIL**

The Order will contain exemptions to permit waiting for the purposes of boarding or alighting, loading or unloading, building and demolition, removal of obstructions, removal of furniture, maintenance or essential services, funeral purposes, delivering or collection of postal packets and for vehicles issued to or used by disabled drivers which display an orange badge.

## SUNDERLAND BOROUGH COUNCIL

*The Borough of Sunderland (Eden House Road/Hurstwood Road Area) (Restriction of Waiting) Order 1981*

Notice is hereby given that the Council of the Borough of Sunderland, pursuant to arrangements made under section 101 of the Local Government Act 1972 and with the Tyne and Wear County Council in exercise of powers conferred by section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974, and of all other enabling powers have made an Order the effect of which is to provide that no person shall, except upon the direction or with the permission of a police constable in uniform or traffic warden, cause or permit any vehicle to wait between the hours of 8 a.m. and 6 p.m. Mondays to Fridays along both sides of the lengths of roads specified in the Schedule to this notice.

Certain exceptions are contained in the Order. These exceptions include waiting for the purpose of enabling:

- (a) the picking up of or the setting down of passengers;
- (b) goods to be loaded onto or unloaded from the vehicles;
- (c) disabled persons' vehicles to wait for up to 2 hours; and where necessary in connection with:
- (d) the maintenance of the roads; and
- (e) the supply of gas, water or electricity.

The reason for the Order is to alleviate the problem of congestion caused by indiscriminate parking and in the interests of road safety.

A copy of the Order which comes into operation on 22nd June 1981 and a plan showing the length of road concerned may be examined at:

- If not exceeding 10 lines of printed matter: £20·25.
- For each additional 5 lines or under: £7·20.
