Unless the Order is suspended or quashed as a conse Unless the Order is suspended or quashed as a consequence of any such application, any person who on 9th July 1981 has had an interest in land having lawful access to a highway to which the Order relates may claim to be entitled to be compensated by the Blyth Valley Borough Council in respect of any depreciation in the value of his or her interest which is directly attributable to the Order and of any other loss or damage which is so attributable. Any claim must be served on the council at its above address within a period of 6 months from 9th July 1981 unless the period is extended in any particular case by the Secretary of State.
