HIGHWAYS ACT 1980

The District Council of Castle Point, Benfleet Road (B1014 Classified Road) (Side Roads) Order 1981

The Secretary of State for Transport hereby gives notice that he has confirmed the above Order which was made by the District Council of Castle Point, under sections 1, 3 and 62 of the Highways Act 1971, which has effect as if made under sections 14 and 125 of the Highways Act 1980, and which, as confirmed, provides for authorising the Council:

- (a) to carry out improvements to Lynton Road, St Johns Road and Hadleigh Park Avenue at their junction with Benfleet Road;
- (b) to stop up a length of Lynton Road, all on or in the vicinity of the route of the classified road which the Council are proposing to improve at Hadleigh, Benfleet, in the county of Essex.

AVON COUNTY COUNCIL

The County of Avon (A370, Long Ashton By-Pass, City of Bristol and District of Woodspring) 40 m.p.h. Speed Limit Order 1981

Notice is hereby given that on 9th July 1981 the County Council of Avon made an Order under sections 74 (1) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and with the consent of the Minister of Transport.

SOUTH YORKSHIRE COUNTY COUNCIL

The South Yorkshire County Council (St. Sepulchre Gate and High Street, Doncaster) (Experimental Prohibition of Driving) Order 1980 (Extension No. 2) Order 1981.

A further exception to the Order will permit a vehicle to proceed in the lengths of road referred to in paragraph 1 of this notice to be loaded or unloaded from those premises situated in those lengths of road referred to in paragraph 1 of this notice.
