In accordance with paragraphs 3(i) and 8 of the Certificates of Tax Deposit Prospectus (Series 5) dated 31st July 1980 the Treasury hereby give notice that the Schedule to the said Prospectus (Series 5) dated 31st July 1980 shall be amended by the addition of the following liabilities:
