The Trunk Roads (40 m.p.h. Speed Limit) (No. 13) Order 1981
Ashchurch Road, Ashchurch, Gloucestershire

The Secretary of State for Transport hereby gives notice that he has made an Order under section 74 (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968. The effect of the Order, which comes into force on 25th August 1981, will be that no person will be permitted to drive any motor vehicle at a speed exceeding 40 m.p.h. on that length of the Bath-Lincoln Trunk Road (A438) at Ashchurch in the Borough of Tewkesbury in the county of Gloucestershire which extends from the junction of Ashchurch Road with the western side of the roundabout at M5 Junction No. 9 (the Ashchurch Interchange), to a point 643 metres east of its junction with Northway Lane. This length of road is at present an unrestricted one for speed limit purposes. The Order is required to reduce the significant number of accidents over this length of the trunk road.

The Order as made will be complemented by Gloucestershire County Council's proposals for limiting traffic speed on that

length of Ashchurch Road immediately west of the Interchange roundabout which will come into force on the same date.

- (k) the existing prohibition of right turns from St. Paul's Lane into St. Paul's Road will be revoked;
- (l) the existing prohibition of right turns from Littledown Road into Lansdowne Road South will be revoked;
- (m) that section of St. Swithun's Road Service Road from its junction with Knyveton Road to its junction with Christchurch Road will be a one-way street in a northerly direction.

- (a) prohibit waiting at all times on all sides of that section of St. Paul's Road comprising the new dual carriageway from and including the new roundabout at the junction with Holdenhurst Road in a northerly direction to but excluding the new roundabout at the junction with Wessex Way;
- (b) prohibit waiting at all times on all sides of the cul-de-sac fronting Nos. 33 to 37 St. Paul's Road;
- (c) prohibit waiting at all times on all sides of the service road at the southern end of St. Paul's Road;
- (d) prohibit waiting at all times on all sides of that section of Waverley Road comprising the new dual carriageway from its junction with St. Swithun's Road in a northerly direction to but excluding the new roundabout at the junction with Holdenhurst Road;
- (e) prohibit waiting at all times on all sides of that section of St. Swithun's Road comprising the new dual carriageway from but excluding the roundabout at the junction with Christchurch Road in a northerly direction to the junction with Waverley Road;

- (f) prohibit waiting at all times on the whole western side of that section of St. Swithun's Road (Service Road) from its junction with Knyveton Road to its junction with Christchurch Road;
- (g) prohibit waiting at all times:
 - (A) (i) on both sides of that section of St. Swithun's Road from Holdenhurst Road to a point 17 metres (55 feet) south of Southcote Road;
 - (ii) on both sides of that section of St. Swithun's Road from its southern extremity for a distance of 21 metres (70 feet) in a northerly direction including all sides of the turning circle at the southern end of the road;
 - (B) the eastern side of that section of St. Swithun's Road from a point 9 metres (30 feet) north of Frances Road to a point 9 metres (30 feet) south of Frances Road;
- (h) prohibit waiting at all times and on all sides of that section of Knyveton Road from its junction with St. Swithun's Road dual carriageway in an easterly direction for a distance of 61 metres (200 feet);
- (i) prohibit waiting at all times on the northern side of that section of Southcote Road from a point 20 metres (66 feet) east of St. Swithun's Road for a distance of 31 metres (100 feet) in an easterly direction;
- (j) prohibit waiting at all times on all sides of those sections of Lansdowne Road North:
 - (i) from its junction with Wimborne Road to the western boundary of No. 27 Lansdowne Road, and
 - (ii) from a point 72 metres (235 feet) north of the southern leg of Cavendish Road in a southerly direction to its junction with Lansdowne Road South;
- (k) prohibit waiting at all times on all sides of that section of Lansdowne Road South from its junction with Lansdowne Road North to its junction with the Lansdowne;
- (l) prohibit waiting at all times on all sides of that section of Lansdowne Road North Service Road fronting Nos. 42 to 48 Lansdowne Road North;
- (m) prohibit waiting at all times on all sides of that section of St. Paul's Lane from its junction with St. Paul's Road dual carriageway in a westerly direction for a distance of 34 metres (110 feet);
- (n) limit waiting to one hour in any two hours between 7 a.m. and 7 p.m. on the northern side of that section of St. Paul's Lane from a point 34 metres (110 feet) west of St. Paul's Road dual carriageway for a distance of 113 metres (370 feet) in a westerly direction;
- (o) prohibit waiting at all times between 7 a.m. and 7 p.m. along the northern side of that section of St. Paul's Lane from a point 147 metres (450 feet) west of St. Paul's Road dual carriageway to its junction with Lansdowne Road South and along the southern side of that section of St. Paul's Lane from a point 34 metres (110 feet) west of St. Paul's Road dual carriageway to its junction with Lansdowne Road;
- (p) prohibit waiting at all times on all sides of Littledown Road Service Road leading off St. Paul's Lane, on all sides of the said Service Road east of Dean Park Road eastern section, on the northern side of that section of Littledown Road from its junction with St. Paul's Road dual carriageway for a distance of 38 metres (125 feet) in an easterly direction, and on the southern side of that section of Littledown Road from its junction with St. Paul's Road dual carriageway for a distance of 37 metres (120 feet) in an easterly direction;
- (q) prohibit waiting between 8 a.m. and 7 p.m. along the northern side of that section of Littledown Road from its eastern extremity for a distance of 47 metres (155 feet) in a westerly-direction and along the southern side of the said section of Littledown Road for a distance of 34 metres (110 feet);
- (r) prohibit waiting at all times on all sides of the eastern section of Dean Park Road from a point 123 metres (405 feet) south of its junction with Cavendish Road southern link road in a southerly direction to its junction with Littledown Road Service Road;
- (s) prohibit waiting at all times on all sides of the south-eastern link road joining Cavendish Road to Lansdowne Road North;
- (t) prohibit waiting at all times on all sides of Waverley Road Service Road;

- (w) prohibit waiting at all times on the north-western side of that section of Holdenhurst Road from a point 95 metres (315 feet) south-west of the new roundabout at its junction with St. Paul's Road for a distance of 22 metres (72 feet) in a south-westerly direction with exemption for hackney carriages;
- (x) prohibit waiting at all times on the north-western side of that section of Holdenhurst Road from a point 117 metres (385 feet) south-west of the new roundabout at its junction with Waverley Road for a distance of 33 metres (108 feet) in a south-westerly direction;
- (y) prohibit waiting at all times on the eastern side of that section of Holdenhurst Road from a point 67 metres (220 feet) south of the new roundabout at its junction with Waverley Road for a distance of 46 metres (150 feet) in a southerly direction;
- (z) limit waiting to one hour in any two between the hours of 10 a.m. and 7 p.m. on the eastern side of that section of Holdenhurst Road from a point 9 metres (30 feet) north of its junction with Cotlands Road to a point 113 metres (370 feet) south-west of its junction with the new roundabout at its junction with Waverley Road;
- (aa) limit waiting to one hour in any two between the hours of 10 a.m. and 7 p.m. on the western side of that section of Holdenhurst Road from a point 64 metres (210 feet) south-west of the new roundabout at its junction with St. Paul's Road to a point 95 metres (313 feet) south-west of the roundabout;
- (ab) limit waiting to one hour in any two between the hours of 10 a.m. and 7 p.m. on the western side of that section of Holdenhurst Road from a point 150 metres (493 feet) south-west of the St. Paul's Road roundabout to a point 116 metres (380 feet) north-east of the Lansdowne;
- (ac) prohibit waiting at all times on all sides of that section of York Road from its junction with St. Swithun's Road dual carriageway for a distance of 18 metres (60 feet);
- (ad) prohibit waiting between the hours of 10 a.m. and 7 p.m. on the northern side of that section of York Road from a point 18 metres (60 feet) west of St. Swithun's Road dual carriageway to its junction with Cotlands Road;
- (ae) prohibit waiting between the hours of 10 a.m. and 7 p.m. on the southern side of that section of York Road from a point 90 metres (295 feet) west of St. Swithun's Road dual carriageway to its junction with Cotlands Road;
- (af) limit waiting to one hour in any two between 10 a.m. and 7 p.m. on the southern side of that section of York Road from a point 18 metres (60 feet) west of St. Swithun's Road dual carriageway for a distance of 72 metres (235 feet) in a westerly direction.

The usual exceptions will apply to loading and unloading goods, picking up and setting down passengers and certain works.

THE GREATER MANCHESTER COUNTY COUNCIL

The Greater Manchester County (Trafford Road/Chester Road, Old Trafford) (Prohibition of 'U' turn) (County) Order 1981

Notice is hereby given that the Greater Manchester County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be to prohibit vehicles from making a 'U' turn from the easterly carriageway of Trafford Road, Stretford into the westerly carriageway of Chester Road (A56).

There are exemptions in the proposed Order for vehicles used for police, ambulance and fire brigade purposes.
