PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 28th October 1981 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices of Oakham with Hambleton and Egleton; and Braunston with Brooke, in the diocese of Peterborough.

2. Uniting the benefices of Alkington with Yeaveley; and Cubley with Marston Montgomery, in the diocese of Derby.

3. Uniting the benefices of Shipston on Stour with Tidmington; and Honington with Idlecote, in the diocese of Coventry.

4. Uniting the benefices of Whatfield with Semer; and Nedging with Naughton, and altering the areas of the parishes of Bildeston with Wattisham; and Nedging, in the diocese of St. Edmundsbury and Ipswich.

5. Substituting the church of All Saints, Eastleigh, in the diocese of Winchester as the parish church of the parish of Eastleigh; and declaring redundant the existing parish church of The Resurrection, Eastleigh.

6. Uniting the benefices of Ross; Brampton Abbotts; and Bridstow with Peterstow, in the diocese of Hereford, and establishing a team ministry for the area of the new benefice.

7. Uniting the benefices of St. George, Kenwyn, and St. John, Kenwyn, in the diocese of Truro.

8. Uniting the benefices of Broad-town; and Clyffe Pyppard and Tockenham, in the diocese of Salisbury.

9. Declaring redundant the church of All Saints', Bathpool, a chapel of ease in the parish of West Monkton, in the diocese of Bath and Wells.

10. Dissolving the benefices of Mundesley and Paston with Knapton; transferring the parish of Mundesley, Paston and Knapton to the benefice of Trunch, in the diocese of Norwich; and extending the Trunch team ministry to include these parishes.

11 (1) Uniting the parishes of Tysoe and Compton Wynyates;

(2) uniting the benefices of Tysoe with Compton Wynyates and Oxhill; and Watcote;

(3) declaring redundant the parish church of the parish of Compton Wynyates, in the diocese of Coventry; and

(4) appropriating the redundant building and annexed land to use as a private chapel and purposes ancillary thereto.

12. Uniting the benefices of Sherston Magna with Easton Grey; and Luckington with Alderton, in the diocese of Bristol.

13. Uniting the benefices of Somerton with Compton Dundon; and Charlton Adam with Charlton Mackrell and Kingsdon, in the diocese of Bath and Wells.

14. Uniting the benefices of Foulsham, Hindolveston and Guestwick, in the diocese of Norwich.

15. Uniting the benefices of Hinton Martel; Horton and Chalbury; and Witchampton and Hinton Parva, Long Crichel with Moor Crichel; in the diocese of Salisbury, and establishing a team ministry for the area of the new benefice.

16. (1) Dissolving the benefice of Long Burton, Folke, North Wootton, Haydon and Caudle Purse, and re-arranging its constituent parishes;

(2) effecting a transfer of a share of the patronage of the benefice of The Caundles and Holwell and altering the name of the benefice; and

(3) uniting the benefices of Buckland Newton; Pulham; and Wootton Glanville with Holnest, in the diocese of Salisbury.

17 (1) Providing a new place of worship for the parish of St. James, Hatcham, in the diocese of Southwark;

(2) declaring redundant the old parish church and appropriating it with part of the churchyard to use for educational purposes; and
