

Exceptions will permit waiting for:

- (a) picking up and setting down passengers,
- (b) loading or unloading goods,
- (c) disabled persons,

and where necessary, in connection with:

- (d) the maintenance of the road, and
- (e) the supply of gas, electricity and water, or of any telegraphic line as defined in the Telegraph Act 1878.

Full details of the proposals are in the draft Order, which, together with a map showing the restricted road and a statement of the council's reasons for proposing the Order, may be examined at the Solicitor's Department, Town Hall, South Shields, during normal office hours.

If you wish to object to the proposed Order, you should send the grounds for your objection in writing to the undersigned by 15th February 1982.

WANDSWORTH BOROUGH COUNCIL

ROAD TRAFFIC REGULATION ACT 1967 AS AMENDED BY PART IX OF THE TRANSPORT ACT 1968  
Putney Controlled Parging Zone—Amendments to Parking Places

Notice is hereby given that the Council of the London Borough of Wandsworth is applying to the Greater London Council for Orders to be entitled:

- (a) the Wandsworth (Parking Places) (No. ) Order 198 under sections 35-37, 40 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968; and
- (b) the Wandsworth (Waiting and Loading Restriction) (Amendment No. ) Order 198 under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and section 24 (2) of and Schedule 6 to the Road Traffic Act 1974.

2. The general effect of the proposed Orders would be to revoke certain metered parking places in Werter Road and introduce a loading ban on additional lengths of Werter Road and extend the hours of restriction on waiting by vehicles in lengths of Werter Road.

3. The General effect of the Wandsworth (Parking Places) (No. ) 198 would be to:

- (a) revoke the designation by the Wandsworth (Parking Places) (No. 1) Order 1977 or the Wandsworth (Parking Places) (No. 1) Order 1980, as the case may be of certain 2-hour parking places on the highway listed in Schedule 1 of this notice;
- (b) designate parking places on the highway specified in column 1 of Schedule 2 to this notice at which charges may be made by the Council for vehicles authorised by the Order to be left in those parking places;
- (c) provide that the type of parking place, the maximum initial period, the rate of charge, the excess period and the excess charge payable to the Council in respect of metered parking places would be as set out in columns 2, 3, 4, 5, 6 and 7 respectively of the said Schedule 2;
- (d) provide that the parking places would operate between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (e) provide that the vehicles which may be left in a metered parking place the maximum initial period of which is two hours shall be passenger vehicles (12 seats or less), goods carrying vehicles, motor cycles and invalid carriages;
- (f) provide that any unexpired time shown on a parking meter may be used free of charge and the period during which a vehicle may not return to a metered place will be one hour;
- (g) provide that certain vehicles may wait free of charge in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (20 minutes) and vehicles left by specified disabled persons (no time limit).

4. The general effect of the Wandsworth (Waiting and Loading Restriction) (Amendment No. ) Order 198 would be to further amend the Wandsworth (Waiting and Loading Restriction) Order 1976, so that:

- (a) the hours of restrictions imposed by the Wandsworth (Waiting and Loading Restriction) Order 1976 on waiting by vehicles in parts of Werter Road would be varied from 8.30 a.m. to 6.30 p.m. Mondays to Saturdays inclusive to 8 a.m. to 6.30 p.m. Mondays to Saturdays inclusive.
- (b) further lengths of Werter Road would be subject to restriction on waiting by vehicles for the purposes of delivering or collecting goods or loading or unloading a vehicle between the hours of 8 a.m. and 6.30 p.m. Mondays to Saturdays inclusive.

5. The prohibitions referred to in 4 (a) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g. the picking up or setting down of passengers; the carrying out of statutory powers or duties; to licensed street traders etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply.

6. The restrictions imposed by the Wandsworth (Waiting and Loading Restriction) Order 1976 would apply to any area previously designated as parking places and not redesignated as such, as they apply in the immediate vicinity.

7. A copy of each of the proposed Orders, of the Orders referred to in 3 and 4 above (and of the Orders which may have previously amended or applied those Orders) of the map which indicates each road to which the Orders relate and of the Council's statement of reasons for applying for the Orders may be inspected at the under-mentioned offices between the times stated until 12th February 1982:

- (a) The Concourse, The Town Hall, Wandsworth High Street, London S.W.18, Monday to Friday 9 a.m. to 4.45 p.m.
- (b) Putney Library, Disraeli Road, Putney, London S.W.15, Monday, Tuesday, Wednesday and Friday 10 a.m. to 8 p.m., Thursday 10 a.m. to 1 p.m., Saturday 9 a.m. to 5 p.m.

8. Any person desiring to object to the proposed Orders should send a statement in writing of his objections and the grounds thereof to the Controller of Transport and Development (bearing Ref. TD/HT/O/PK), Greater London Council, The County Hall, London SE1 7PB, stating the grounds thereof, within the above mentioned 21 days.
