THE HIGHWAYS ACT 1980

The Cardiff—Llangurig Trunk Road (Abercynon—Pentre-bach Diversion Side Roads) Order 1979 (Variation) Order

The Secretary of State for Wales hereby gives notice that he proposes, in relation to the above-mentioned Trunk

Road between Abercynon and Pentrebach in the county of Mid Glamorgan, to make under sections 14, 125 and 236 of the Highways Act 1980 an Order which will:

- (a) vary the Cardiff—Llangurig Trunk Road (Abercynon—Pentrebach Diversion Side Roads) Order 1979 as varied by the Cardiff—Llangurig Trunk Road (Abercynon—Pentrebach Diversion Side Roads) Order 1979 (Variation) Order 1981, with respect to:
 - (i) the improvement, raising, lowering or other alterations of highways,
 - (ii) the stopping up of highways and a private means of access, and
 - (iii) the construction of new highways,

all between Abercyon and Pentrebach aforesaid; and (b) provide for the transfer of the said new highways to the County Council of Mid Glamorgan as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.

WR11/5/20, and stating the grounds of objection.
