*The Greater Manchester County (Broad Street/Crescent (A6) and Albion Way (A5063), Salford) (40 m.p.h. Speed Limit) (County) Order 1982.*

Notice is hereby given that the Greater Manchester County Council intend to apply to the Secretary of State for Transport for consent to the making of an Order under section 74 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 the effect of which will be to prohibit the driving of any motor vehicle at a speed exceeding 40 m.p.h. on the following lengths of road, at present being constructed as part of the Cross Lane Diversion/Windsor Bridge Improvement Scheme:

*Broad Street/Crescent (A6 Improvement)*, from a point 60 metres west of the westerly kerb-line of Adelphi Street to a point 120 metres east of the easterly boundary of the Broughton East Roundabout, a distance of approximately 1,470 metres.

*Albion Way (A5063)*, from the A6 to a point 195 metres south of the southerly kerb-line of Liverpool Street, a distance of approximately 670 metres.
