The Clwyd County Council (Public Footpaths Nos. (Part) 13 and 23, Community of Llanfair Dyffryn Clwyd) Public Path Extinguishment Order 1982.

Notice is hereby given that the above-named Orders, made on 9th March 1982, are about to be submitted to the Secretary of State for Wales for confirmation, or to be confirmed as upopposed Orders by the Clwyd County Council.

- (1) To create a new Public Footpath running from the A494 trunk road at a point north-east of Pwll-glas village by the turning to Llanfair Dyffryn Clwyd ogrid reference 126552) and along the old railway track in a south-westerly direction towards Pwll-glas village to the point where the track crosses the bridge over the River Clwyd (grid reference 122548) and then turning in an easterly direction to connect with Public Footpath No. 9 in the Community of Llanfair Dyffryn Clwyd at grid reference 123548.
- (2) To create a new Public Footpath running from Public Footpath No. 9 aforesaid at the bend at grid reference 121547 in a general southerly direction through field Ordnance Survey Enclosure No. 1967 to connect with Public Footpaths Nos. 11 and 12 near Graig Isaf (at grid reference 121545).
- (3) To extinguish that section of Public Footpath No. 9 near Pwil-glas and in the Community of Llanfair Dyffryn Clwyd District of Glyndwr and County of Clwyd running from Eyarth Lodge opposite Plas Isaf (grid reference 128552) initially along the drive to the rear of Eyarth House and then through Eyarth House Wood as far as grid reference 123548
- (4) To extinguish Public Footpath No. 13 near Pwll-glas and in the Community of Llanfair Dyffryn Clwyd aforesaid branching out of Public Footpath No. 9 (at grid reference 125550) and running past the rear of Eyarth House to Public Footpath No. 10 east of Graig Uchaf (at grid reference 125543).
- (5) To extinguish Public Footpath No. 23 near Pwll-glas and in the Community of Llanfair Dyffryn Clwyd aforesaid running from Graig-Adwy-Wynt at Pont Eyarth Uchaf (grid reference 128549) to Public Footpath No. 9 in Eyarth House Wood (at grid reference 126550).
