The Borough of Gateshead (The Hermitage, Whickham) (Prohibition of Waiting) Order 1982

MID GLAMORGAN COUNTY COUNCIL

Mid Glamorgan County Council (Wigan Terrace (A4065) (Part) Bryncethin) (Prohibition of Waiting) Order 1982

Notice is hereby given that on 25th March 1982 the Mid Glamorgan County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be to prohibit the waiting of vehicles at any time on the southern side of Wigan Terrace (A4065) Bryncethin, from a point at the termination of the current waiting restriction, 20 metres (22 yards) from its junction with the Bryncethin to Tondy Principal Road (A4065) in a south-easterly direction for a distance of 10 metres (11 yards).

The Order came into operation on 1st April 1982 and a copy thereof and a map showing the length of road to which the Order relates may be inspected at the offices of the Mid Glamorgan County Council, Cathays Park, Cardiff, during normal office hours until the end of 6 weeks from 1st April 1982.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended or on the grounds that any requirement of that Act as so amended or of

any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from 1st April 1982 apply to the High Court for this purpose.

EAST HERTFORDSHIRE DISTRICT COUNCIL

East Hertfordshire District Council (B1004 (Great Hadham Road) Bishop's Stortford) (30 m.p.h. Speed Limit) Order (No. 79) 1980.

HUMBERSIDE COUNTY COUNCIL

The County of Humberside (East Yorkshire Borough) (Esplanade, Bridlington) (Experimental Pedestrianisation and One-Way Traffic) Order 1982.

Notice is hereby given that the Humberside County Council propose to make a Road Traffic Regulation Order, the effect of which will be to impose the following restrictions on traffic movement in part of Esplanade, Bridlington. These restrictions will be for an initial experimental period of twelve months.

(a) *One-Way Traffic and Direction*

Esplanade, from its junction with Marlborough Terrace to its junction with Cliff Street, from north to south.

(b) *Prohibition of Driving except for loading and unloading and No Waiting at any time*

Esplanade, from its junction with Regent Terrace to its junction with Marlborough Terrace.

Fourth Schedule, that part of the west side of Esplanade from its junction with Marlborough Terrace to its junction with Regent Terrace.
