The London-Yorkshire Motorway (M1) (Toddington-Brogborough) (Temporary Prohibition of Traffic) Order 1982

Notice is hereby given that the Secretary of State for Transport has made an Order on the London-Yorkshire Motorway (M1) in Bedfordshire.

The Order, which has been made to enable works to The Order, which has been made to enable works to be carried out, will be in operation, when the appropriate signs are erected, from 4th April 1982 until such time as the works have been completed. The works are expected to be completed by 25th June 1982.

The effect of the Order will be:

(i) to authorise the prohibition of traffic on either of the carriageways of the Motorway between Junction 12 (Toddington) and marker post 750, which is north of Junction 13 (Brogborough);

(ii) to permit vehicles to travel on the hard-shoulder;

(iii) to allow two-way traffic to operate in the opposite

(iii) to allow two-way traffic to operate in the opposite carriageway to that in which the works are being carried out;

(iv) to authorise the closure of the slip roads at Junction 13.

Alternative Routes

During the periods of closure of the slip roads drivers should follow the temporary diversionary routes as indicated by traffic signs.
