## ROAD TRAFFIC REGULATION ACT 1967

*The County of Hereford and Worcester (Restricted Roads) (No. ) Order 1982 (30 m.p.h. Speed Limit) (C203 Cusop Dingle Road, Cusop).*

Notice is hereby given that the County Council of Hereford and Worcester propose to make an Order under sections 72 (3) and 73 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and of all other enabling powers the effect of which will be to impose a speed limit of 30 m.p.h. on the following length of road in the Parish of Cusop in the District of South Herefordshire in the County of Hereford and Worcester:

C203, *Cusop Dingle Road*, from its junction with the B4348 Hay-on-Wye to Dorstone road for a distance of 608 metres (1,995 feet) in a southerly direction to its junction with the UC851 Cusop Dinle to the Church road.

A copy of the draft Order and map showing the length of road affected and a copy of the County Council's statement of reasons for proposing to make the Order can be inspected from Monday to Friday during normal office hours at:

## ROAD TRAFFIC REGULATION ACT 1967

*The County of Hereford and Worcester (Faraday Road and Red Barn Drive, Hereford) (Restriction of Waiting) Order 1982.*

Notice is hereby given that on 25th March 1982 the County Council of Hereford and Worcester made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and of all other enabling powers the effect of which will be to restrict waiting between the hours of 8 a.m. to 6.30 p.m., Monday to Friday inclusive, on the following lengths of roads in the City of Hereford in the County of Hereford and Worcester:

*Faraday Road*, both sides:

- (i) From its junction with Grandstand Road in a southerly direction to its junction with Red Barn Drive, a distance of 108 metres (354 feet).
- (ii) From its junction with Red Barn Drive in an easterly and southerly direction to its termination at the entrance to Sun Valley Poultry Ltd., a distance of 348 metres (1,141 feet).

*Red Barn Drive*:

- (i) North side, from its junction with Faraday Road in a westerly direction for a distance of 60 metres (197 feet).
- (ii) South side, from its junction with Faraday Road in a westerly direction to its junction with Poultry Lane.

The Order will come into operation on 16th April 1982.

A copy of the Order as made and a copy of the relevant map can be inspected at County Hall, Spetchley Road, Worcester, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act or on the ground that any requirement of that section or of section 84A, 83B or 84C of the Act of 1967 or of any regulations made under the said section 84C has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order was made (such date stated in this notice) make application for the purpose to the High Court.

## ROAD TRAFFIC REGULATION ACT 1967

*The County of Hereford and Worcester (Lodge Road and Marsden Road, Redditch) (Prohibition of Commercial Vehicles of Over 7.5 tonnes) Order 1982.*

Notice is hereby given that on 25th March 1982 the County Council of Hereford and Worcester made an Order under section 9 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and of all other enabling powers the effect of which will be to prohibit any heavy commercial vehicle the maximum gross weight of which exceeds 7.5 tonnes to proceed in the following lengths of roads in the Borough of Redditch in the County of Hereford and Worcester:

- (1) *Marsden Road*, between its junction with Union Street and its junction with Summer Street,
- (2) *Lodge Road*, between its junction with Union Street and its junction with Summer Street.

The Order will come into operation on 5th April 1982.

A copy of the Order as made and a copy of the relevant map can be inspected at County Hall, Spetchley Road, Worcester, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act or on the ground that any requirement of that section or of section 84A, 84B or 84C of the Act of 1967 or of any regulations made under the said section 84C has not been complied with in relation to the Order, may within 6 weeks of the date on which the Order was made (such date stated in this notice) make application for the purpose to the High Court.

## ROAD TRAFFIC REGULATION ACT 1967

*The County of Hereford and Worcester (The Trinity, Worcester) (Prohibition and Restriction of Waiting) Order 1982.*

Notice is hereby given that the County Council of Hereford and Worcester propose to make an Order under sections 1 (1), (2), (3) and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and of all enabling powers the effect of which will be:

- (1) to prohibit waiting at any time on that side and sides of lengths of road in the City of Worcester in the County of Hereford and Worcester as described in the First Schedule to this notice;
- (2) to prohibit waiting between the hours of 8 a.m. and 6.30 p.m. on Monday to Saturday inclusive on the side of length of road in the City of Worcester in the County of Hereford and Worcester as described in the Second Schedule to this notice.

Exemptions in the proposed Order will permit waiting for the purpose of:

- (a) picking up and setting down passengers;
- (b) loading and unloading goods;
- (c) delivering and collecting mail by Post Office vehicles;
- (d) delivering and collecting furniture and effects with Police consent;
- (e) any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply of gas, electricity and water and maintenance of telegraphic lines;
- (f) the fire brigade, ambulance or police services.

Exemptions in the Order also permit disabled persons' vehicles displaying a badge and parking disc issued under the Local Authority's Orange Badge Scheme:

- (a) to wait on the lengths of road specified in the First Schedule to this notice for a maximum of 2 hours (return prohibited within 1 hour).
- (b) to wait at any time on the length of road specified in the Second Schedule.
