NORTHUMBERLAND COUNTY COUNCIL

The County of Northumberland (Cattle Market, Hexham) (Prohibition of Waiting) Order 198

Notice is hereby given that the Northumberland County Council propose to make an Order under section 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended.

The effect of this Order, if made, will be:

(1) to revoke that part of the current waiting limited to 30 minutes restriction which applies between 8 a.m. and 7 p.m. each day to the south side of Cattle Market, Hexham (B6305) from a point 5 metres east of the junction with the Hexham-Blanchland Road (B6306) eastwards for 34 metres, and

(2) to prohibit waiting between 8 a.m. and 7 p.m. each day on the south side of Cattle Market, Hexham (B6305) from a point 5 metres east of the junction with the Hexham-Blanchland Road (B6306) eastwards for approximately 34 metres. Exemptions will be included in the Order to allow the picking up and setting down of passengers, the loading/unloading goods and for certain other necessary purposes.

A copy of the draft Order which together with a map showing the area involved and a statement of the Council's reasons for proposing to make the Order, may be examined at the offices of the Chief Executive, Tynedale District Council, Council Offices, Hexham House, Hexham, and at the address given below during normal office hours.

Any person who wishes to object to the proposals should send the grounds for their objections in writing to the undersigned by 14th May 1982.
