Notice is hereby given that on 30th March 1982 the Waverley District Council made an Order under section 31 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 and Schedule 6 to the Local Government Act 1974.

The Order, which will come into operation on 5th April 1982, will increase the charges in the short term car parks, the charges for season tickets in all car parks and the excess charges. The former Cattle Market car park will be renamed South Street car park and season tickets will not be available for use in that car park. The Order applies to the parking places named in the Schedule to this notice, which shows the class of vehicle, the days and times of operation, the maximum period for waiting and the scale of charges for each parking place.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968, the Local Government Act 1972 and the Local Government Act 1974, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 30th March 1982 apply to the High Court for this purpose.

The County Borough of Wallasey (Various Streets) (Prohibition and Restriction of Waiting) Order No. 3, 1971 (Amendment No. 3) Order 1981.

Notice is hereby given that Wirral Borough Council pursuant to arrangements made under section 101 of the Local Government Act 1972, with the County Council of Merseyside propose to make an Order under sections 1 (1), (2), (3) and 84C (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974.

The effect of the Order will be to prohibit the waiting of vehicles at the times and in the lengths and sides of roads specified in the Schedule.

Exceptions will be provided in the Order to permit the picking up and setting down of passengers, loading and unloading of goods, in pursuance of statutory powers and duties, disabled persons parking and hackney carriages to wait upon authorised stands.
