The Trunk Road (Manor Way, Cardiff) (Box Junction) Order 1982

Notice is hereby given that the Secretary of State for Wales has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, which shall come into operation on 14th April 1982. The effect of the Order will be to establish a box junction on that length of the Cardiff-Glan Conwy Trunk Road (A470) known as Manor Way at its junction with Caegwyn Road at Cardiff in the County of South Glamorgan.
