HAMPSHIRE COUNTY COUNCIL

The Hampshire County Council (Width Restriction in the New Forest)

Notice is hereby given that Hampshire County Council proposes making a Road Traffic Regulation Order as follows:

Effect of Order: The existing restrictions preventing vehicles which exceed 6 foot 6 inches in width from proceeding in the Road U106 (including the former C31) between its junctions with the C159 at Moyles Court, C17 at Janesmoor Plain and the C17 at Emery Down will be

lifted from those sections, now severed, which connected Milkham Enclosure and Bolderwood coach park with the A31 at Bratley Arch and imposed on the new length of U106, which passes beneath the A31 Trunk Road, and connects Milkham Enclosure and Bolderwood coach park direct. The existing exemption for coaches trevelling to or from the Bolderwood coach park will apply over the new direct route.

The weight restriction on the Millyford Bridge on the U106 (formerly C31) west of Lyndhurst is removed.
