

SHROPSHIRE COUNTY COUNCIL

The County Council of Shropshire (St. John's Road, Ludlow) (Prohibition of Driving) Order 19

Notice is hereby given that the Shropshire County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended.

When this Order comes into effect no person shall cause or permit any vehicle to proceed in the length of road specified in the Schedule of this notice.

Full details of this proposal are in the draft Order which, together with the relevant plan and a statement of the County Council's reasons for proposing to make the Order, may be examined during usual office hours at The Shirehall, Abbey Foregate, Shrewsbury, and at South Shropshire District Council Offices, Stone House, Corve Street, Ludlow.

That length of St. John's Road which extends from its junction with Lower Broad Street for a distance of 1 metre in an easterly direction.

YORK CITY COUNCIL

The City of York (Various Streets) (Limitation of Waiting) Order 1982

Notice is hereby given that on 31st March 1982 the York City Council, pursuant to arrangements made under section 107 of the Local Government Act 1972 with the North Yorkshire County Council in exercise of the County Council's power under sections 1, 9 and 84D (1) of the Road Traffic Regulation Act 1967, as amended, made an Order, the effect of which will be to introduce the following restrictions:

(a) 60 minute limited waiting (with no return within one hour), 8 a.m. to 6 p.m., Monday to Saturday, on the north-east side of Piccadilly from a point 32 metres to the south-east of its junction with the south-east kerb of Merchantgate for a distance of 50 metres in a south-easterly direction.

(b) 90 minute limited waiting (with no return within 2 hours), 8 a.m. to 6 p.m., Monday to Saturday:

(i) on the south-east side of Margaret Street from a point 70 metres from its junction with Walmgate for a distance of 27 metres in a north-easterly direction.

(ii) on the west side of George Street from a point 10 metres to the south of its junction with the southern kerb-line of Lead Mill Lane for a distance of 45 metres in a southerly direction.

(c) 60 minute limited waiting (with no return within one hour), 9.15 a.m.-4 p.m., Monday to Saturday, on the south-east side of the Stonebow from a point 15 metres to the north-east of its junction with the north-east kerb-line of Hungate for a distance of 40 metres in a north-easterly direction.

The Order comes into effect on 6th April 1982.

The limited waiting in The Stonebow will initially operate for an experimental period of 6 months; the other measures are permanent.

A copy of the Order, together with the map showing the lengths of road affected, may be seen at my office during normal business hours.

Any person who wishes to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may, within 6 weeks from 31st March 1982, make application to the High Court for this purpose.

WEST YORKSHIRE METROPOLITAN COUNTY COUNCIL

The West Yorkshire Metropolitan County Council (Leeds) (Traffic Regulation) (No. 23) Order 1981

Notice is hereby given that the West Yorkshire Metropolitan County Council propose to make the above Order under their powers in the Road Traffic Regulation Act 1967, as amended, the effect of which will be:

(a) To prohibit waiting by vehicles from 8 a.m. to 6 p.m. on Mondays to Saturdays in lengths of Ingram Row, Ingram Street, Jack Lane (north side), Manor Road, Marshall Street, Ninevah Road (north side), St. Barnabas Road, Sweet Street, Sweet Street West, Trent Street and Walton Street, at Holbeck, Leeds.

(b) To limit waiting to 1 hour (return prohibited within 1 hour) between 8 a.m. and 6 p.m. on Mondays to Saturdays in short lengths of Siddall Street (east side), and Sweet Street (north side) at their junction at Holbeck.

WEST YORKSHIRE METROPOLITAN COUNTY COUNCIL

The West Yorkshire Metropolitan County Council (Kirklees) (Traffic Regulation) (No. 5) Order 1982

Notice is hereby given that the West Yorkshire Metropolitan County Council propose to make the above Order under their powers in the Road Traffic Regulation Act 1967, as amended, the effect of which, in so far as it relates to roads at Huddersfield, will be:

(a) To prohibit waiting by vehicles at all times in lengths of Beck Road, Bradford Road/Northgate, lay-by on the east side of Bradford Road (at its junction with Alder Street), Bradford Road link, Connecting Road between Oxford Street and Northgate (opposite Green Street), Green Street, Lower Viaduct Street and Oxford Street.
