The West Yorkshire Metropolitan County Council (Wakefield) (Traffic Regulation) (No. 23) Order 1981

Notice is hereby given that the West Yorkshire Metropolitan County Council propose to make the above Order under their powers in the Road Traffic Regulation Act 1967, as amended, the effect of which, in so far as it relates to roads at Castleford in the the Wakefield Metropolitan District will be:

- (iii) to limit waiting to 1 hour return prohibited within 4 hours between 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive in further lengths of Aire Street, Aire Street (Service Road), Back Wesley Street and St. Oswald Street.

NOTICE OF CONFIRMATION OF PUBLIC PATH DIVERSION ORDER

TOWN AND COUNTRY PLANNING ACT 1971

The Metropolitan Borough of Bolton (Footpath 32 Little Lever) Public Path Diversion Order 1982

Notice is hereby given that on 26th March 1982, the Bolton Metropolitan Borough Council confirmed the above-named Order.

The effect of the Order, as confirmed, is to divert a length of the public right of way shown as Footpath 32 Little Lever which runs over land off Stopes Road, Little Lever from a point A, 39 metres to the east of Settle Street to Settle Street. The diversion will run in a southerly direction from point A for a distance of 33 metres to a point C and in a westerly direction for a distance of 39 metres to a point D on Settle Street.

A copy of the confirmed Order and the map contained in it has been deposited at Room 115, Town Hall, Bolton and may be inspected free of charge at all reasonable hours.

This Order becomes operative on the date on which it is certified by the Bolton Metropolitan Borough Council that the provisions of Article 2 of the Order have been complied with, but if any person is aggrieved by the Order and desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971 or on the grounds that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under section 244 of the Town and Country Planning Act 1971 within 6 weeks from 9th April 1982 make application for the purpose to the High Court.
