NOTICE OF APPLICATION TO VARY LICENCES TO ABSTRACT WATER

Notice is hereby given that an application is being made to the Southern Water Authority by A. C. Hulme & Sons, of Great Pedding, Wingham, Canterbury, Kent, to vary the following licences for Spray Irrigation, Serial Numbers 9/40/4/72/SR, 9/40/4/73/SR and 9/40/4/74/SR.

The variations applied for are as follows:

9/40/4/72/SR Land at Shalmsford Farm, Canterbury, Kent.

Spray Irrigation: April-September.

To increase the annual rate to 5,000,000 gallons.

To increase the daily rate to 250,000 gallons.

To increase the hourly rate to 20,000 gallons.

The boundary of the land within which the irrigation can take place is to be changed. The details are on maps available at Shalmsford Farm during the period shown below.

Trickle Irrigation: From River Stour, approximately Grid Ref. TR 090 551 to TR 092 553: 3,500,000 gallons per year, 144,000 gallons per day, 6,000 gallons per hour, May to July.

To increase the daily rate to 250,000 gallons.

To increase the hourly rate to 20,000 gallons.

9/40/4/74/SR Land adjacent to the Wingham River, near Wingham.

TR 562 257 to TR 572 256:

To increase the daily rate to 250,000 gallons.

To increase the hourly rate to 20,000 gallons.
