

(S.I., 1973, No. 1351, S.I., 1979, No. 1426 and S.I., 1981, No. 1085) give notice that they hereby restrict recognition of the Official Certificates reproduced in Part I of the First Schedule to the notice published in the *London Gazette* dated 23rd January 1969 and in the Schedules to the notices published in the *London Gazette* dated 21st August 1973 and 13th July 1979 for the importation of meat and meat products from Denmark, to the extent shown in the Schedule hereto.

The notice published in the *London Gazette* dated 30th October 1981 is hereby revoked.

**NOTE:** Imports of meat and meat products from certain countries are restricted, and in some cases prohibited, on animal health grounds by the Importation of Animal Products and Poultry Products Order 1980, as amended. The recognition of an Official Certificate for public health purposes does not give exemption from such restrictions or prohibitions. (17 SI)

**IMPORTED FOOD REGULATIONS 1968 (AS AMENDED)**

*Czechoslovakia: Official Certificate*

The Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales acting jointly in exercise of the powers conferred on them by the Imported Food Regulations 1968 as amended by the Imported Food (Amendment) Regulations 1973, 1979 and 1981 (S.I. 1973 No. 1351, S.I. 1979 No. 1426 and S.I. 1981 No. 1085)

hereby recognise, subject to the conditions hereinafter set out, the Official Certificates of which particulars are given in Part I of the Schedule hereto as showing:

- (a) that the meat to which it relates or the meat from which the meat product to which it relates was prepared, was derived from mammals inspected before and after death and passed in accordance with criteria satisfactory to the Ministers, and
- (b) that the preparation and packing was carried out with all necessary precautions for the prevention of danger to health.

Recognition is subject to the following conditions:

- (a) Recognition applies only to meat and meat products imported from Czechoslovakia.
- (b) Where the Official Certificate is in the form of a stamp, recognition will apply only if the stamp is clearly impressed or otherwise marked on the meat or meat product and on the package containing the meat product.
- (c) Where the Official Certificate is in the form of a label, recognition will apply only if the label is securely affixed to the meat or meat product and to the package containing the meat or meat product, and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate.
- (d) Recognition is restricted to the extent shown in Part 2 of the Schedule hereto.

The notices published in the *London Gazette* dated 1st January 1965 and 10th February 1976 are hereby revoked.

**SCHEDULE**


**PART I**

The Official Certificate for specified fresh meat shall consist of a stamp or label bearing the following details within an oval surround 6.5 cm wide by 4.5 cm high:

- on the upper part:
  - the word Czechoslovakia in capitals or, if appropriate the set of initials for that country under the International Convention on Motor Vehicle Registration, viz: CS.
- in the centre:
  - the number of the establishment.

The letters must be 0.8 cm high and the figures 1 cm high. The seal may include an indication of the official veterinarian who carried out the health inspection of the meat.

The Official Certificate for meat products excluding those derived in whole or in part from poultry meat shall consist of a stamp or label of the following design:



The above certificate may be stamped, impressed or otherwise marked on the meat product as well as to any container in which the meat product is packed. The mark may be reduced in size for smaller inner cartons, pouches, sachets, cans etc., provided that it is legible, indelible and its characters easily distinguishable.

Both Official Certificates will be completed by the insertion of the establishment number.
