

15. Providing a new place of worship for the parish of Luton, Christ Church, in the diocese of Rochester and for the redundancy and demolition of the existing parish church and the disposal of its site and of an adjoining detached burial ground.
16. Uniting the benefices of East Allington; Slapton; and Street, in the diocese of Exeter.
17. Transferring the parish of St. James, Huncote, from the benefice of Croft and Huncote to the benefice of Narborough and uniting the benefices of Croft and Huncote; and Stoney Stanton, in the diocese of Leicester.
18. Creating the new parish of All Cannings within the benefice of Bishop's Cannings, All Cannings and Etchinghampton, in the diocese of Salisbury.
19. Altering the areas of the parishes of Glenfield; St. Aidan, Leicester, and St. Anne, Leicester, in the diocese of Leicester and incorporating in those parishes the extraparochial place known as Braunstone Frith.
20. Uniting the benefices of Ockley and Okewood, in the diocese of Guildford.
21. Establishing a group ministry for the benefices of Bath Abbey with St. James; and Bath, St. Michael with St. Paul, in the diocese of Bath and Wells.
22. Uniting the benefices of Newnham, and Awre and Blakeney, in the diocese of Gloucester.
- 23.—(1) Rearranging the following benefices and their constituent parishes:

 (2) declaring redundant the church of St. John the Baptist and the Seven Maccabees, Cookbury, and
 (3) transferring a share of the patronage of the benefice of Shebbear, Buckland Filleigh, Sheepwash and Highampton, in the diocese of Exeter.
- 25.—(1) Providing a new place of worship for the parish of St. Matthew, Westminster, in the diocese of London;
 (2) declaring redundant and partly demolishing the existing parish church, and incorporating the remainder, and part of its site and annexed land, in the said new place of worship; and
 (3) empowering the said Commissioners to sell or lease the remainder of the said site and land.
26. Uniting the benefices and parishes of All Souls, Leicester; St. Andrew, Leicester; and St. Nicholas, Leicester, in the diocese of Leicester, and establishing a team ministry for the area of the new benefice.
27. Uniting the benefices of Christ the King, Bury, and The Most Holy Trinity, Bury, in the diocese of Manchester, and establishing a team ministry for the area of the new benefice.
28. Uniting the benefices and parishes of Emmanuel, Lockwood; and Rashcliffe, in the diocese of Wakefield.
29. Uniting the benefices and parishes of The Ascension, Hulme; and St. George, Hulme, and declaring redundant the parish church of St. George, Hulme, in the diocese of Manchester.
30. Making the Redundant Churches Fund responsible for the care and maintenance of the redundant church of St. Peter, Kingerby, in the diocese of Lincoln.
31. Demolishing the redundant church of St. Columba, North Gosforth, in the diocese of Newcastle, and empowering the said Commission to dispose of its site and annexed land.

32. Appropriating the redundant church of St. Nicholas, Wattisham, in the diocese of St. Edmundsbury and Ipswich, to be given for use as a monument.

TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Registrar's Office (Bank Buildings) at the Bank of England on Friday, 2nd July 1982 at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968 to the amount of £100,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the tenderer on any business day from Monday, 5th July 1982 to Friday, 9th July 1982 inclusive and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one new halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Tenders must be made on the printed forms which may be obtained from the Bank of England.
